In accordance with the Maryland Nonstock Corporation Act, Section 5-206, if quorum is not present at the Annual Meeting the meeting will be rescheduled. As stated in section 5-206 of the Maryland Nonstock Corporation Act, section C; at the additional meeting, the number of members present in person or by proxy at the rescheduled meeting will constitute a quorum. A majority of the members present in person or by proxy may approve or authorize the proposed action at the additional meeting and may take any other action which could have been taken at the original meeting if a sufficient number of members had been present.

The rescheduled Annual meeting will elect two (2) members to the Board of Directors, review completed projects and upcoming plans for 2014 and approve the final budget. **NOTE: there is an INCREASE for the Townhomes** due to the Storm Water Rain Tax, more explanation to follow at the meeting and on the website.
